

The Strategic Imperative


The Challenge



Operational fragmentation across continents. Disparate systems and inconsistent standards hindered efficiency.

- 8-12 core business functions centralized
- 15+ global locations consolidated
- 500+ employees migrated
- 200+ business processes standardized

Why GCCs Matter



GCCs consolidate expertise, harness global talent, and drive transformation through cost efficiency and consistent standards.



Four Critical Challenges



Capability Assessment Gaps

Lacked unified view of existing processes. Uncertain where centralization could drive maximum impact across global units.



Structure Ambiguity

Operations spread across regions made defining robust structure with clear reporting lines difficult. Risk of unclear responsibilities.



Standardization Obstacles

Variability in controls and procedures created compliance challenges and diluted best practices across business units.



Transition Risk

Concerns about service disruption, loss of local insight, and workforce resistance during critical activity migration.
